

FINANCIAL POLICY

As a convenience for our patients we have added **Henghold Surgery Center (HSC)**, a state of the art Ambulatory Surgery Center (ASC) that is connected to our main office at 530 Fontaine Street. We are now able to offer patients who need a more extensive repair after their Mohs procedure a one-stop option. Henghold Surgery Center is accredited by the Accreditation Association for Ambulatory Health Care (**AAAHC**) and the State of Florida Agency for Healthcare Administration (**AHCA**). We meet and exceed all regulatory requirements.

Once your physician determines the area treated by the Mohs procedure is clear, and your repair is determined to be more complicated or extensive (skin flap or graft), then you are able to walk down the hall to the ASC for the repair. At this facility we are able to provide a higher level of anesthesia to maximize your comfort. In addition, there is less disruption to your personal time by not having to schedule another day to have this done at an outpatient hospital, and the ASC saves you financially because it is less expensive than a hospital outpatient facility. If you are treated in the ASC, you will need a driver to be present and available to drive you home.

Henghold Surgery Center is a separate facility and is billed separately. HSC is contracted with many insurance companies to be “in-network”, but not all. Your insurance policy will determine how much out of pocket will be your responsibility. Our Insurance Specialist will be happy to discuss with you if HSC is “in-network” for your insurance plan and what your policy allows prior to your procedure.

Our contract with the insurance companies dictates that we collect co-payments, co-insurance, and any deductibles at the time of service. We accept Discover, MasterCard®, Visa®, local check or cash for your charges.
